claims against "Petters Group Worldwide, LLC, Petters Company, Inc., Nationwide

Resources, Inc., Thomas J. Petters, Deanna Coleman a/k/a Deanna Munson, Robert

White, Larry Reynolds, and John and Jane Does 1 through 10." (See Claim 34.)

Accordingly, True North Funding appropriately filed a claim against PGW and its votes

should have been included by the United States Trustee.

Because the ultimate outcome of the election described in the Report filed by the

United States Trustee is not affected by inclusion of True North's vote, True North has

not filed a motion to resolve any dispute, but merely files this Objection to the Report to

preserve the issue should it arise in any other context.
